#### Resident concern:

- Consider adding a fitness station along the walking trails including items for upper body exercises as well as crunches. Items will be low maintenance but be usable for both adults and youth. Possible location would be by basketball courts or in field area off Holly Leaf.
- Resident questioned how the Board intends to pay off the loan necessary to renovate the pool house. Will the facility be sitting unused throughout the fall and winter? From Board:
   Community facility will be rented out in the future to help recoup payment for the facility. As for use, based on feedback received to date from community members, the facility will be in high demand year round for hosting parties and other such events in the community room.

- Researched any possible negative impact of HUD project being constructed down Minnieville

- Received estimate for cost to replace the inlays in the community sign at the front of the community. Estimate is \$1,700 per inlay.

# Management report:

- Obtained cost to produce inlays for community sign and passed to Board president
- Lighting proposal obtained for community entrance sign.
  - Dominion VA Power has 2 junction boxes in the vicinity of the community sign
    - 1 box cannot be used because it's considered a main transformer box and the power company will not allow any outside connection to that box
    - Other box is in a homeowner's front yard and would end up with an exterior meter added to the junction box.
    - Estimate for single light installation for community sign is \$8,000
    - Other consideration is a solar powered light; estimate is \$6,200
    - Will table lighting project to see if prices go down or it can be budgeted as a future project.
    - Consider approaching local school(s) about presenting their solution to this project and offer a payment to them if project is used. – homeowner suggestion
- Glitch in closing of loan for pool project: Capital One requested additional information at the last minute that did not seem prudent.
- Request for Proposal (RFP) sent to pool companies to obtain proposals for 2014 pool contract.

## Pool report:

- Updated Statement of Work to be sent out to various pool companies to obtain proposals for the pool contract for 2014.

#### **New Business:**

- Signatures to be obtained from President and Treasurer of Board for Wells Fargo to allow them to make withdrawals from CD's they hold.
- Letter received from Turner, Leins & Gold, LLC to request that we sign with them for the next 2
  years to handle the audit of the community's financial statements to be signed by President of
  Board.
