# President's report:

- Issue with contractors going door-to-door despite being a "no soliciting" neighborhood
  - Resident can take promotional material from contractor and contact PWC nonemergency line to report or advise contractor of "no soliciting' signs around neighborhood

# Pool report:

- Mats finally on the floors in the bathrooms to prevent slips and falls
- Andro Tomic (GHA Services rep)
  - o Final occupancy permit and final inspection still being held by county and not given to us
    - PWC wants a fresh air calculation and kitchen to be ADA accessible despite approving all plans prior to the start of the project
      - GHA hoping that changing wording of kitchen to galley or kitchenette will hinder the need for ADA compliance
  - o Presented the most accessible gas fireplace to the Board
    - In contact with a subcontractor for Washington Gas to get an estimate of how much it will cost the HOA to run gas to the poolhouse
      - Requiring that this issue is resolved before September meeting
    - 90-120 days to install gas line once estimate and approval received
  - Push bars on egress gates will not be installed until building inspector comes to sign off after MEP (mechanical, electrical, plumbing) inspections take place
  - Board agreed to a 30,000 BTU gas fireplace that is 42" wide and matched rendering previously voted on
