Meeting Minutes April 18, 2017

#### Resident concern:

- Stafford-based law firm is doing a "Hometown Heroes" program and is looking to get the word out. Advised resident to use Facebook page to advertise program
- Request that we advise Palmer Landscaping not to use their riding mowers on the eroding hill next to the pool. Brian will contact Palmer and make this request.
- Date requested for neighborhood cleanup: June 10<sup>th</sup>, yard sale is June 3<sup>rd</sup>
- Neighbor concerned about impending new renter's dog jumping over the fence into their yard. Advised neighbor to notify GHA if there is a problem as well as discuss with dog owner.
- Requesting lighting along the walking path back in the corner near Omisol. Do not want to light the path and provide any sort of expected safety management once the sun goes down.
- Consider hydroseeding eroding hill by pool
- When will PWC Service Authority fix Maple Ridge at intersection with Holly Leaf? Board does not know.
