#### **New Business:**

- Exterior of clubhouse is in need of repairs estimates provided by TYL Inc and Ark Services
  - TYL Inc was a far more thorough in their review of the clubhouse and necessary repairs
    - Provided options to repair clubhouse and retaining wall around baby pool (now) and then separate option to replace retaining wall around baby pool (fall time)

Motion to engage TYL Inc to proceed with recommended clubhouse repairs totalling \$8,645: 1 C Fillinger 2 I White: APPROVED

#### Management report:

- Pool is being filled with water today so we will find out if the reconstruction of it was successful very soon.
- Landscaping proposals received and outlined above
- Trash removal proposals received
  - Bids obtained from 5 companies including current one, American Disposal
  - All companies to pick up trash twice a week and recycling once a week and provide rolling bins for both types of refuse
  - Rates from ~\$17/house to ~\$19/house
