June 16, 2020

Neighbor concerns:

- Pertaining to black bear that was in the neighborhood the bear stopped and was eating food that a neighbor leaves birdseed in the yard all year long. This is a major concern as it can/will attract wildlife that is not safe in the neighborhood
- Neighbor questioning the stairs next to the pool and the inconsistent rise on the steps themselves. This was the result of the contractor having to work with prior repairs that were made to the stairs. The HOA has decided to leave them be rather than incur additional cost to repair 2 steps. A suggestion was made to post a sign at the top and bottom of the stairs advising walkers of the uneven stairs. The Board will look at instituting this.
- With a \$7K savings from the pool season and a \$7K refund from the water company, a neighbor requested that the Board discuss a possible decrease in assessments for 2021.

President's report:

- Executive session is a special piece of each meeting where sensitive data is discussed that pertains to individual residents that should not be discussed in an open forum. - Paths were trimmed up
- Caitlin to walk paths to see about berry bushes along path that may need to be trimmed back

Pool/Clubhouse Report:

- Recapped decision made during pool special meeting pool will remain closed until guidelines are released for Phase 3 at which time, another special meeting will be had to discuss how to proceed
- All pool repairs have been completed in time for pool season to start
- Residents are questioning a possible refund since pool expenses are not what they're normally expected to be.
 - This was investigated and it was determined that it would cost more to process a refund for each homeowner than what the refund would actually be
 - Instead the Board is exploring a 0% increase in HOA dues for 2021
